While many CV residents and parents await this mailer to sign up for athletic passes, your participation and gift allows the Eagle Foundation to provide a multitude of opportunities to students that go far beyond entrance to athletic events! Your generosity and support to the annual campaign allow the Foundation to provide MANY student opportunities that would not be funded otherwise.

The Eagle Foundation is a non-profit organization that works hard to provide additional educational opportunities for students in K-12 classrooms across all 11 buildings. Since 1996, our mission has been to provide supplemental resources and services that complement the District's goals and curriculum. Key annual program expenditures include a mentoring program, reading/math booster sessions, first-grade readiness sessions, classroom learning grants, enrichment camps and academic scholarships.

This year, donors giving \$125 or more will be eligible to receive two athletic passes good for admission to all regularly scheduled home athletic events in 2019-2020. If you pledge by August 2, your name will be included in the Eagle Foundation donor list printed in the football program and various recognition lists.

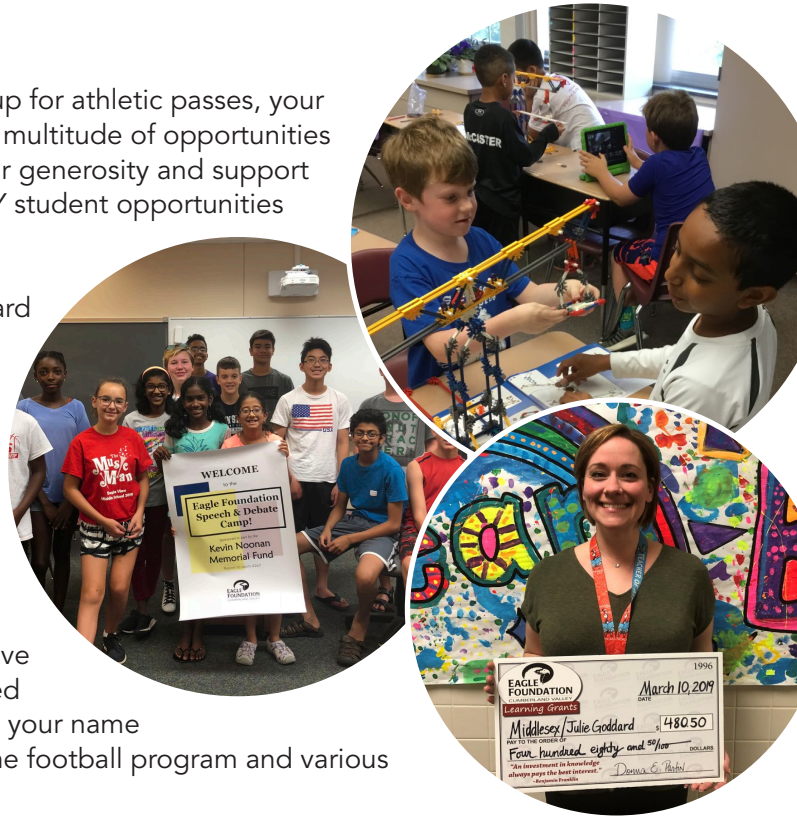

Eagle Enthusiasts \$10,000 or more

Donor recognition at the Eagle Enthusiast level, (6) tickets to the Spring musical [▲], plus (2) reserved seat tickets for 2019 home football games and (2) athletic passes*. Special VIP passes to a District reception and events plus an Eagle Enthusiast level donor gift.

Gold Circle \$5,000 - \$9,999

Donor recognition at the Gold Circle level, (4) tickets to the Spring musical [▲], plus one reserved seat ticket for 2019 home football games and (2) athletic passes*. Special VIP passes to a District reception and events plus a Gold Circle level donor gift.

Silver Circle \$1,000 – \$4,999

Donor recognition at the Silver Circle level, (2) tickets to the Spring musical [▲], plus one reserved seat ticket for 2019 home football games and (2) athletic passes*.

Bronze Circle \$500 – \$999

Donor recognition at the Bronze Circle level, (2) tickets to the Spring musical [▲], plus one reserved seat ticket for 2019 home football games and (2) athletic passes*.

Red & White Circle \$125 – \$499

Donor recognition at the Red & White Circle level, plus one reserved seat ticket for 2019 home football games and (2) athletic passes*.

Friends of CV \$1 – \$124

Donor recognition as a supporter at the Friends of CV level.

To be included in the donor list within the football program, contributions must be received by **August 2, 2019**. Those eligible to receive athletic passes **will receive them in the mail** shortly after the contribution is recorded at the Foundation office.

If you take advantage of collecting your athletic passes and/or reserved home football tickets, you are ineligible to claim that portion of your contribution as a tax deduction since the value of the items exceeds your contribution. Contact your personal tax advisor for further details.

* Athletic passes are good for admission to *regularly scheduled* home athletic events within the 2019-2020 season. Passes must be used by the individual whose name appears on the pass and cannot be transferred.

[▲] Includes premium reserved tickets to the spring musical (no ordering necessary). Musical tickets will be mailed to you in advance for one of the selected performances.

Employer Matching Gift

Please note: Most company matching gift policies include a clause that will not match a gift if the employee benefits as a result of the contribution. If you take advantage of the athletic passes or other gifts, most likely you would be ineligible for a matching contribution. Your gift may be doubled or more if you or your spouse are employed by a company that matches employees giving to an education organization. Contact your personnel office.
